



## Installation Notes

Mini UV LED is typically used for mini split systems and other limited space applications. Because space is tight the best place for mounting the LED lights is usually inside the supply vent with the light shining onto the blower wheel (which is prone to the worst mold growth).



Cutaway view of typical Mini UV LED® installation in mini split




# **CAUTION UV LED LIGHT**

Prolonged exposure to direct LED UV light may be harmful to eyes & skin. Disconnect power before servicing. Indirect exposure (blue glow) is not harmful.


## **IMPORTANT!**

Install LED strip so that the light shines into the air system, not into the room.



# **LED Strip Mounting**

- 1. Determine the best location for the LED Strip and clean that area with the alcohol wipe.
- **2.** If needed shorten the LED strip by 4" segments (cut only between copper squares on strip).
- **3.** Pass the connector cable through the drilled hole.
- **4.** Peel off paper from the adhesive backing on the LED strip a few inches a time and press it down firmly onto the clean surface.



**IMPORTANT!** Place the LED strip so the light will shine on blower wheel and mold prone areas, NOT INTO THE ROOM.

## **Power Supply Installation**



Note: Some indoor systems


may require additional wiring

Mini UV LED power supply.

- **1.** Remove the control box cover and connect the wiring harness as shown.
  - LED Driver wiring • Black to hot terminal • White to neutral (typically S1 & S2


#### Wiring Diagram\*



\* Mini UV LED comes with a 120, 208, 240 VAC driver (power supply)

**3.** Insert the UV lamp cable connectors and wiring harness connector into the power supply.






- **4.** Tuck the power supply into the line chase on the back of the ac unit or place it in or under the control box or other secure location.
- **5.** Return power to the system and confirm that Mini UV LED is working.
- **6.** Apply the UV warning sticker in an appropriate location.

#### **Optional Switch Installation**

- Select an appropriate location for the on/off switch on the mini-split access panel that is within 12" of the LED driver 12 VDC AMP connector.
- 2. Drill a <sup>7</sup>/<sub>8</sub>" hole and insert switch.
- **3.** Connect switch in series between driver and LED strip using the AMP connectors.
